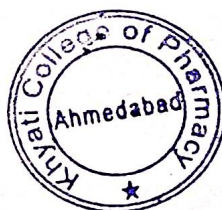

4. Aware all students for ragging abuse and their disadvantages.

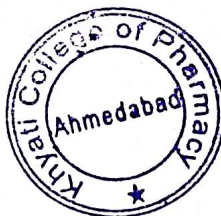

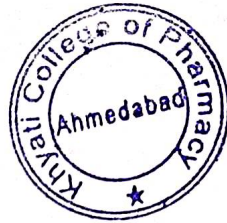

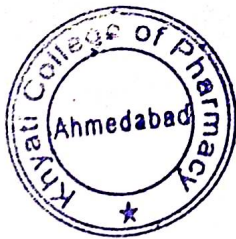
